



## Competition Agreement 2012 (16U)

This document, between the Committee of the Southern California International Softball Festival Champions Cup, acting on behalf of the 2012 Champions Cup (16U) tournament, and \_\_\_\_\_ (team name) is a binding contract that specifies, in part, the terms by which the team listed above will be certified to compete in the 2012 Champions Cup (16U) tournament. These terms (requirements) include:

- I. **Entry Fees** – The 2012 Champions Cup (16U) entry fee is \$875.00. All entry fees are due upon acceptance into the tournament. Payment may be made by check or money order, payable to The Champions Cup. Once a team is accepted into the Champions Cup, no refunds will be issued.
- II. **Disqualification** – The Champions Cup (16U) reserves the right to remove an individual or team from competition at any time due to conduct considered detrimental or harmful to the ideals or spirit of the Champions Cup (16U), its staff, volunteers, officials, fans, or other participants.
- III. **Withdrawal** – In the event that any team has not qualified for their national championship tournament and is entered in a national championship qualifying tournament during the same time as the Champions Cup (16U), that team must either confirm their withdrawal from the national qualifying tournament by **Monday, June 11**, or they will be removed from the Champions Cup (16U) on that date and replaced with a team from the waiting list. The Champions Cup (16U) is not responsible for any costs or cancellation penalties incurred by any team removed from the tournament under this provision.
- IV. **Hotels** – The Champions Cup (16U) requires that all participants are bound by the terms as stipulated in the Hotel Agreement. Failure to comply will result in immediate exclusion from the tournament.
- V. **Coach/Managers Meeting** – Option to attend 18/Gold Coaches Clinic Tuesday, July 10, 2012 (additional fee required)
- VI. **Completion of Competition** – All teams must agree to complete all games assigned to them, both in pool play and championship play. Please be aware that the championship game is scheduled to begin **at (NOON ) on Monday, 9<sup>th</sup> of July**. All teams are required to make travel arrangements that will allow them to complete the tournament, up to and including the championship game.
- VII. **Deadlines** – The Champions Cup (16U) asks that you comply with the deadlines to submit requested information and material. These items, and the dates that they are required to be submitted, include:

**MAY 31, 2012** – Hotel Reservation Confirmation Form (the preceding will be sent via email to accepted teams)  
**June 15, 2012** - proof of ASA registration and insurance, ASA travel permit (if needed); Roster Form
