



Competition Agreement 2018 (18u/Gold)

This document, between the Committee of the Southern California International Softball Festival Champions Cup, acting on behalf of the 2018 Champions Cup (18u/Gold) tournament, and _____ (team name) is a binding contract that specifies, in part, the terms by which the team listed above will be certified to compete in the 2018 Champions Cup (18u/Gold) tournament. These terms (requirements) include:

- I. **Entry Fees** – The 2018 Champions Cup (18u/Gold) entry fee is **\$1150.00**. All entry fees are due with the application and payment may be made by check or money order, payable to **The Champions Cup**. Once a team is accepted into the Champions Cup, no refunds will be issued.

Deadlines – Paperwork NO LATER than dates below (early is good) **mail PAPERWORK PLEASE**

- (1) _____ **May 7, 2018** --- **PROOF of USA SOFTBALL registration (receipt registration or Bollinger Insurance Certificate)**
- (2) _____ **May 21, 2018** – **Hotel Confirmation Form (2018 18u) (form – hotel chosen and number of rooms reserved) out of area only**
- (3) _____ **June 4, 2018** **#1 Team Roster Form #2 Summary of Wrist Band by Graduation Year (f/ College Coaches Booklet)**

- II. **Disqualification** – The Champions Cup (18u/Gold) reserves the right to remove an individual or team from competition at any time due to conduct considered detrimental or harmful to the ideals or spirit of the Champions Cup (18u/Gold), its staff, volunteers, officials, fans, or other participants.
- III. **Withdrawal** – In the event that any team has not qualified for their national championship tournament and is entered in a national championship qualifying tournament during the same time as the Champions Cup (18u/Gold), that team must either confirm their withdrawal from the national qualifying tournament by **Monday, June 4, 2018** or they will be removed from the Champions Cup (18u/Gold) on that date and replaced with a team from the waiting list. The Champions Cup (18u/Gold) is not responsible for any costs or cancellation penalties incurred by any team removed from the tournament under this provision.
- IV. **Hotels** – The Champions Cup (18u/Gold) requires that all participants are bound by the terms as stipulated in the Hotel Agreement. Failure to comply will result in immediate exclusion from the tournament.
- V. **Coach/Managers Meeting** – All teams entered should send at least one team official to the Manager's meeting, to be held prior to the beginning of tournament competition. This meeting will cover rules, tournament details and any late changes that may occur.

Completion of Competition – All teams must agree to complete all games assigned to them, both in pool play, elimination bracket and championship play. Please be aware that the championship game is scheduled to begin at **5:30 PM on Sunday, 15th of JULY**. All teams are required to make travel arrangements that will allow them to complete the tournament (**early communication with Tournament Directors for prior approval if extenuating exception are required**) up to and including the championship game.
